### Hear from Deloitte's pioneer batch of Singapore QP graduates

When the Singapore QP was first introduced in 2013, a group of dedicated fresh graduates from Deloitte took on the challenge and invested their time and effort to embark on this journey. After nearly three years of hard work and perseverance, they have reaped the rewards and done us proud by becoming the inaugural batch of Singapore QP graduates. This is both a great personal and professional achievement, so let's hear what our pioneer batch of Deloitte Singapore QP graduates have to say about the experience.

### Q. What made you decide to embark on the Singapore QP?

**Chua Chin Ann (Audit Senior):** It presented a good opportunity for me to build on the knowledge learnt from university and gather industry insights from peers and facilitators. Its overseas recognition was also an incentive due to the future career opportunities it could provide.

**Tania Harsono (Audit Senior):** The Singapore QP is a rigorous programme which trains accounting professionals in key areas of accounting. Knowing this, I chose to go through it because I wanted to prepare myself for the future, as it would force me to work hard in order to learn and grasp the different accounting concepts.

**Juan Kusuma (Audit Senior):** It was a personal challenge to develop professionally, and I believe that Singapore QP will open doors of possibilities in the future.

**Q.** What were some challenges you encountered and how did you overcome them? *Tania Harsono (Audit Senior):* Although juggling work and studies was quite a challenge at times, I made sure that I was disciplined and well prepared for each workshop to benefit fully from the programme. Sitting through modules with my Deloitte friends also helped, as we would prepare for the workshops together by having joint discussions and continued to support each other through the examination. Having each other's help certainly made our preparation more effective and a lot more enjoyable.

Becky Soh (Audit Senior): The Singapore QP modules leveraged on the knowledge we learned in university, and the actual challenge comes in the form of applying that knowledge to real-life situations. At the time, I was only a Year 1 associate with limited practical experience and this posed a great challenge. Thankfully, I was able to consult my managers who had much more practical experience than me and they were always willing to lend a helping hand.





### Q. How has the Singapore QP benefited you?

Chua Chin Ann (Audit Senior): The workshop sessions exposed me to the various opinions that can arise from real-world issues, but besides that, the friendships and bonds that I have forged with the other candidates are things I will cherish forever.

Juan Kusuma (Audit Senior): The Singapore QP is the bridge between the concepts taught in school and the practical applications at work. I benefitted a lot from the workshop discussions, learning from the differing perspectives of my peers and facilitators.

Becky Soh (Audit Senior): The programme gave me an opportunity to not only improve my technical knowledge, but also brush up on my public speaking skills. I am now able to form opinions quickly and share my thoughts confidently. There were also plenty of networking opportunities and I have even made friends with candidates from other organisations.

### Q. How did Deloitte support you during your Singapore QP journey?

Becky Soh (Audit Senior): As the first batch of candidates, there were plenty of uncertainties such as what the exam format would be like and how to go about seeking pro-bono work. However, I am thankful that Deloitte guided us every step of the way. After each semester, we would have a get-together session with our Training Principal Lee Boon Teck and learning managers to discuss how we have performed, how we can do better and if there are other initiatives that Deloitte can roll out to help all candidates. I'm very thankful for all the support that Deloitte has provided us with, making the journey an enriching one.

Tania Harsono (Audit Senior): Other than financial support, the firm also provided us with ample study leave. Most importantly, we have a very supportive and friendly culture definitely assured us that we were not alone in this Singapore QP journey.



Juan Kusuma (Audit Senior): Deloitte has invested in us greatly during our journey, from technical support to other intangibles which made my Singapore OP experience a positive one. Juan Kusuma (Audit Senior): I am blessed to have a strong support system which constantly reminds me to be disciplined and remain humble at all times.

### Deloitte and you

### Q. What is your current role?

I am currently a Tax Senior with the Global Employer Services division in Singapore who provides individual and partnership tax compliance and advisory services.

### Q. Why did you choose Deloitte?

I was given priority offer to join as a permanent hire at the end of my Year 2 internship with Deloitte. Given the enjoyable time I had during my internship days, I took up the offer and officially joined the Deloitte family in 2013.

### Q. How do you think Deloitte is different from the other Big Four?

Although I have not had any experiences working in the other Big Four firms, I would say that all the Big Four firms are quite similar. However, I feel that Deloitte has a "friendlier" and "family-like" working environment which sets us apart from the rest of the Big Four firms.

### Your advice to undergraduates

Q. What advice would you offer to undergraduates who want to pursue a career in Tax? If you love both writing and Mathematics, tax is for you.

### Q. What advice would you offer to undergraduate in terms of career choices?

Personally, I think the best idea is to find a job that you are passionate about. If you are excited to go to work, you will find yourself motivated and perform better. However, if you are unsure of what job you are passionate about, it would be good to find an employer that provides you with the opportunity to learn and grow. Through which, you may find what you are good at or what you really enjoy doing.

### Q. What can undergraduates expect when working in Tax?

Long working hours during the peak are definitely not uncommon. However, we have implemented the paperless system which allows us to be more flexible in terms of the working hours whereby, we may go home or out for dinner with our friends and family before continuing with our work at home. Other than the working hours, we tend to spend a lot of time communicating with our clients from different background and countries. Through this, you get to hone your communication skill which is a soft skill, valuable by all employers.

### Q. What is the best part of your job?

Nice and encouraging colleagues. When met with challenges, it is nice to have colleagues and managers who are always there to provide me with guidance and support.

### Q. What is the best thing about working in Tax?

Learning how to manage clients and communicating with them effectively, something that comes with hands-on experience.

#### What did you do during your internship?

### What were your key takeaways from the internship?

# My Deloitte So Intern Experience

## Why did you choose Deloitte for your summer internship?

I chose Deloitte because it seemed like a vibrant place to work. I also heard nothing but good things from seniors who are working there.

### What did you do during the internship?

For my internship in the Audit department, I was assigned to work on three different engagements for companies in different industries, which was fun because I had the opportunity to observe and learn different processes. I was in charge of auditing the Profit and Loss Statement, which involved a lot of vouching – I think I vouched over 200 documents in 2 days!

I also got to try out their new Audit software, which was still being rolled out at that time. It was pretty exciting to use a new software that not everyone had the chance to use. I remembered that the full-time staff were still having their training on the software but my manager allowed me to explore it and I used it to prepare 7 Financial Statements over the course of a week.



### What did you like about interning at Deloitte?

I think an internship at Deloitte is very structured. On my first engagement, I was assigned to certain sections of the Income Statement, which is easier for interns and new joiners to understand. Deloitte first-year Audit Associates are in charge of the Income Statement, while second year associates are in-charge of Balance Sheet, which requires more experience. I experienced what the role of a First Year Associate entails and the kind of work that I might be doing in the future. There was always something to do and a lot to learn!

In addition, I like that Deloitte has a well-defined feedback system. It helped me to reflect on my key learning areas and my seniors were very helpful in identifying the areas that I should work on.



### What were some of the most challenging parts of your internship?

I think generally, as an intern, you don't know what you don't know. I remembered occasions when my seniors asked me if I had any questions, and I would be completely silent. It was only when I started performing the assigned tasks did questions start to formulate – and even then, I wasn't sure if I had completely understood the big picture.

There is also the challenge of trying to strike a balance between being inquisitive and asking too many questions. What I found helpful was to note down all the questions I had and then try to figure them out on my own. If there are any questions that I still couldn't work out, I would approach my seniors.



### What have you learned from your internship?

The biggest thing I learned was definitely independence in learning. Starting four weeks late because of academic reasons, I missed the training sessions and had to hit the ground running right from the get-go. I made mistakes along the way, but the seniors were very understanding and coached me with patience, which helped.

I learned not to dwell too much on my mistakes and instead, treat them as learning points. As such, I think I improved as I went along. Whenever I went for interviews, I would like to ask the interviewers what they looked for in interns. Invariably, the number one answer would be a good learning attitude. I never understood why this was so, but after my internship, I did.

### What was your biggest takeaway from the internship?

My biggest takeaway from the internship was a deeper understanding of what the life of a Deloitte auditor entails. Although the roles and responsibilities of an auditor may be largely similar wherever you go, the experience varies widely across different firms. If I were to describe my Deloitte internship experience in a word, it would be immersive.

### What advice would you offer to undergraduates who are going to do an internship?

Understand that the type of work that you get to do and the kind of clients that you meet depends a lot on luck. You could be doing fieldwork in a far-flung corner of Singapore with no wifi, while your peers get to go to a prestigious firm with an all-day buffet. These are things outside your control. What you can control, however, is your attitude. Always keep an open mind and learn as much as possible. Besides your own experience, talk to your fellow interns and your seniors and listen to their experiences too so that you can gain a broader understanding of what the different engagements and job scope is like.



### How has your Deloitte internship benefited you?

The internship has helped me better understand the type of career path that I would like to pursue and the kind of firm that I would like to work in when I graduate.

### Tips for internship:

- 1. Take the time to reflect on what you learnt on a regular basis.
- 2. Ask for feedback and suggestions on how you can improve.
- 3. Instead of saying "I do not know.", say "I'll check with my senior." for all instances when the client asks a question you can't answer.

# Do your research

Before any interview, it is vital to research on the company and role that you have applied for. Review commonly asked interview questions and prepare your responses in advance. Be equipped with as much knowledge of the company as possible.

Examine the skills and characteristics that the job you are applying for demand and position yourself to be the best possible candidate by articulating how your background and

The more prepared you are, the more likely you will be able to present yourself coherently, answer and ask questions that will signal your high interest and leave a lasting impression.



### **Know your timings**

Find out how long your phone interview would take. This information would allow you to plan and gauge how detailed the interview is going to be.

Don't forget to also find out what time the interviewers would be calling so that you would not be caught off guard and unprepared.

Get yourself ready for the call at least 5-10 minutes early because the interviewer can call early.

If the interviewer doesn't provide you with these information, take the initiative to ask. If you are overseas, pay attention to the time zone difference.



### Expect the unexpected

Although many interviewers would contact you beforehand and arrange for a mutually convenient time to conduct the phone interview, some would unexpectedly spring it on you.

Therefore, always be prepared for an unexpected phone interview by doing you know that you will be called for a telephone interview, so that you will not be caught off guard.

If the interviewer calls you on your mobile phone when it's inconvenient for you to speak in private, explain to the the phone interview at a more suitable time.

### Find a quiet place and use earphones

Make sure you are in quiet area where you will be able to hear the person on the other line clearly, so move away from ongoing construction works or heavy traffic.

Get comfortable, sit up straight and make sure that you

Using earphones or any headset gadgets would greatly aid you during your interview because it would free both of your hands to gesture - which would allow you to add emphasis to your voice - and to hold on to whatever materials you have prepared or scribble a quick note



### Get ready the necessary materials

Make sure that you have a copy of your CV and research in front of you before the interview begins.

Have a paper and pen handy, so that you can jot down important information or the answers to your questions.

Don't forget to take down your interviewer's name and email, so that you can follow up with an email after the interview.



### **Listen and smile**

Allow the interviewer to set the stage for the interviewer. Usually the interviewer would do a brief introduction on the company, listen carefully so that you will be able to ask some insightful questions later on. This is also your opportunity to show that you are a good listener too. Smile even though your interviewers will not be able to see your brilliant smile because your tone of voice will be able to reflect it. It would help carry across some energy and excitement when you speak.



### Remember to say your 'thank you'

Wait for an hour or two to pass after the interview and send your thank you note so that you have some time to reflect on the interview. In your email, remember to address the interviewer directly and reiterate your interest in the company and in wanting to meet for a face-to-face interview.





### Upload an appropriate photo

Find or take a high resolution photo of yourself. It could be very easily taken with your mobile phone. Wear a business top and stand in front of a plain background, and put on your best smile!

A LinkedIn page with a profile picture tend to get 14 times more views than those without.



### Update your profile

Fill up all sections of the profile and make it stronger because it provides your potential employers with a comprehensive view and impression of who you are.

### **Keyword optimise** your LinkedIn profile

Use targeted and relevant keywords as it would increase the visibility of your profile.

Think of keywords as words and phrases that the recruiter might actually search for, along with the variations you think might work. One of the easiest ways to find critical keywords would be to browse through job postings. Take note of the unique, job-specific words and the most frequently used terms in both the job descriptions and requirements. Those are the keywords most likely used by employers and recruiters to find qualified job candidates.
